AN ORDINANCE TERMED THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR OF 1973, MAKING APPROPRIATION OF CERTAIN SUMS OF MONEY TO DEFRAY THE NECESSARY GENERAL EXPENSES OF CONDUCTING THE BUSINESS OF THE CITY OF MALTA; LEVYING A TAX TO PROVIDE SAID MONEY FOR THE GENERAL FUND; PROVIDING FOR A CERTIFICATE OF TAXES LEVIED TO THE TAX COLLECTOR OF CASSIA COUNTY, IDAHO; PROVIDING FOR THE APPROPRIATION OF ALL MONEY COMING INTO THE CITY TREASURY; PROVIDING FOR THE PAYMENT OF TAXES SO COLLECTED UP TO $16\frac{1}{2}$ MILLS IN THE GENERAL FUND; AND FIXING THE EFFECTIVE DATE OF THIS ORDINANCE.

8 BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE 9 CITY OF MALTA:

10 Section 1: That there is hereby appropriated for the 11 purpose of paying all of the miscellaneous necessary and all 12 expenses of conducting the business of the City of Malta, or so 13 much thereof as may be necessary as follows:

21 Section 2: There shall be and there is hereby levied 22 in addition to all other taxes, a general ad valorem tax of 23 15 1500.00 for the year 1973, upon all of the taxable property in the City of Malta, Idaho, for the purpose of meeting 24 25 and defraying the general expenses of conducting the business of 26 said City; and that the money realized therefrom shall be placed 27 in a fund to be known as the "General Fund" from which all payments 28 of expenses and indebtedness incurred for the payment of which no 29 other provision is made, shall be paid exclusively.

30 <u>Section 3:</u> All monies authorized from other sources 31 shall be apportioned to the General Fund, except as otherwise 32 provided by law, or ordinance; that this Ordinance be and the same

3 Section 4: The City Clerk shall deliver to the Tax Collector of the County of Cassia, Idaho, a true and correct copy 4 of this Ordinance, duly certified by him, to the office of the 5 Secretary of State of the State of Idaho, for filing therein 6 7 pursuant to Idaho Code 50-1003.

This Ordinance shall be in full force and 8 Section 5: effect from and after its approval, passage and publication as 9 10 provided by law.
