AND SALARIES OF SAID CITY
FOR THE FIRST QUARTER OF
THE YEAR 1977 AND PROVIDING
WHEN THIS ORDINANCE SHALL
BE IN FULL FORCE AND EFFECT.**

**BE IT ORDAINED BY THE MAYOR
AND CITY COUNCIL OF THE CITY OF
MALTA, IDAHO:**

Section 1. That this ordinance is to
be known and designated as the "In-
terim Appropriation Ordinance", which
may be cited as such.

Section 2. That there is hereby ap-
propriated the sum of \$2,000.00 with
which to pay the expenses and
salaries incurred by the City of Malta,
Idaho, during the period of January 1,
1977, to March 31, 1977, while the
Mayor and City Council of said City
prepare the proposed budget of the
City of Malta and adopt the annual
appropriation bill as provided by law.

Section 3. This ordinance shall be in
full force and effect from and after
its passage by the Council and ap-
proval of the Mayor and publication
thereof.

AN ORDINANCE OF THE CITY OF MALTA, CASSIA COUNTY, IDAHO, TERMED "INTERIM APPROPRIATION ORDINANCE" PROVIDING FOR THE APPROPRIATION OF FUNDS FOR THE PAYMENT OF EXPENSES AND SALARIES OF SAID CITY FOR THE FIRST QUARTER OF THE YEAR 1977, AND PROVIDING WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MALTA, IDAHO:

Section 1. That this ordinance is to be known and designated as the "Interim Appropriation Ordinance", which may be cited as such.

Section 2.
