ORDINANCE NO. 31

AN ORDINANCE DECLARING THE INTENT OF THE CITY OF MALTA TO SELL REAL PROPERTY OWNED BY THE CITY, KNOWN AS THE AIRPORT PROPERTY; SUCH SALE TO BE BY PUBLIC AUCTION NOT LESS THAN SIXTY (60) DAYS FROM THE DATE OF THE PASSAGE OF THE THIS ORDINANCE; PROVIDING FOR NOTICE OF PUBLIC HEARING AND APPRAISAL BEFORE SALE.

BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF MALTA, IDAHO:

Section 1.: That it is the intent of the City of Malta to sell certain real property owned by the City, and known as the "Airport Property " at public auction, the property is more particularly described as follows:

Part of the SE% of Section 2 and the NE% of Section 11, in Township 13 South, Range 26 East of the Boise Meridian, Cassia County, Idaho, more particularly described as follows:

The North 100 feet of the SE¼ of said Section 2 and the West 100 feet of the SE¼ of Section 2 and the West 100 feet of the NE¼ of Section 11.

Section 2.: The property to be sold shall be first appraised under the terms and conditions required by the Malta City Council.

Section 3.: Prior to any sale of the property, a public hearing shall be held before the Malta City Council, at which time interested persons may appear and be heard.

Section 4.: Sale of the property shall take place prior to the expiration of sixty (60) days from the date of the

passage of this Ordinance.

Section 5.: The property shall be sold at public auction to the highest bidder and no bid shall be accepted for less than the appraised value; the Council may reject any and all bids; if no bids are received, the City Council shall sell such property for the amount and upon the terms it deems to be in the best interest of the City.

Section 6.: This Ordinance shall be in full force and effect from and after its approval, passage and publication as provided by law.
