## ORDINANCE NO. #66

AN ORDINANCE OF THE CITY OF MALTA, AMENDING SECTION 10-4-1(B) OF THE MUNICIPAL CODE OF THE CITY OF MALTA; ESTABLISHING THE SPEED LIMITS WITHIN CITY LIMITS; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF MALTA:

<u>Section 1</u>. Section 10-4-1 of the Municipal Code of the City of Malta is hereby amended to read as follows:

10-4-1:

- (A) No person shall drive a vehicle on a public thoroughfare, highway, street, road or alley at a speed greater than is reasonable and prudent under the conditions and having regard to the actual and potential hazards then existing. In every event speed shall be so controlled as may be necessary to avoid colliding with any person, vehicle or other conveyance on or entering the public thoroughfare, highway, street, road or alley in compliance with legal requirements and the duty of all persons to use due care.
- (B)Where no special hazard exists that requires a lower speed for compliance with Paragraph (A) of this Section, the speed of any vehicle shall not exceed thirty-five (35) miles per hour. the limits as hereinafter authorized shall be maximum lawful speeds, and no person shall drive a vehicle at a speed in excess of such maximum limits:
  - 1. Thirty five (35) miles per hour on Highways 81 and 77 in the city, or as otherwise fixed and posted by the state of Idaho.
  - 2. Twenty five (25) miles per hour on streets and roads and alleys within the city, unless otherwise posted.
- (C)Upon proper action by the Governing Body, the speed limits on any thoroughfare, highway, street, road or alley within the Municipality may be raised or lowered by posting signs to that effect.

Section 2. The speed limits described in Paragraphs A and B above are hereby established pursuant to Idaho Code section 49-207(2) and shall be maximum lawful speeds, and no person shall drive a vehicle at a speed in excess of such maximum limits.

10-4-1:

(A)No person shall drive a vehicle on a public thoroughfare, highway, street, road or alley at a speed greater than is reasonable and prudent under the conditions and having regard to the actual and potential hazards then existing. In every event speed shall be so controlled as may be necessary to avoid colliding with any person, vehicle or other conveyance on or entering the public thoroughfare, highway, street, road or alley in compliance with legal requirements and the duty of all persons to use due care.

(B) Where no special hazard exists that requires a lower speed for compliance with Paragraph (A) of this Section, the speed of any vehicle shall not exceed thirty-five (35) miles per hour. the limits as hereinafter authorized shall be maximum lawful speeds, and no person shall drive a vehicle at a speed in excess of such maximum limits;

1. Thirty five (35) miles per hour on Highways 81 and 77 in the city, or as otherwise fixed and posted by the state of Idaho.

Twenty five (25) miles per hour on streets and roads and alleys within the city, unless otherwise posted.

(C)Upon proper action by the Governing Body, the speed limits on any thoroughfare, highway, street, road or alley within the Municipality may be raised or lowered by posting signs to that effect.

Section 2. The speed limits described in Paragraphs A and B above are hereby established pursuant to Idaho Code section 49-207(2) and shall be maximum lawful speeds, and no person shall drive a vehicle at a speed in excess of such maximum limits.
